NOTICE IS GIVEN that the Florida Industrial Power Users Group (FIPUG), pursuant to section 366.10, Florida Statutes (1999), and rules 9.030(a)(1)(B)(ii) and 9.110, Florida Rules of Appellate Procedure, appeals to the Supreme Court of Florida Order No. PSC-99-2512-FOF-EI of the Florida Public Service Commission issued on December 22, 1999 in Docket No. 990001-EI. (Order No. PSC-00-0911-FOF-EI issued on May 8, 2000 in the same docket denied FIPUG's Motion for Reconsideration of Order No. PSC-99-2512-FOF-EI. Pursuant to Public Service Commission Rule 25-22.060(1)(c), Florida Administrative Code, a Public Service Commission order is not deemed rendered for purposes of judicial review until the Commission disposes of any motion for reconsideration of such order).

Order No. PSC-99-2512-FOF-EI relates to decisions in the Commission's continuing fuel and purchased power cost recovery and generating performance incentive factor proceedings. FIPUG specifically appeals that portion of the Commission's order relating to its failure to disallow replacement fuel costs for Tampa Electric Company (TECo) which were incurred due to an explosion
