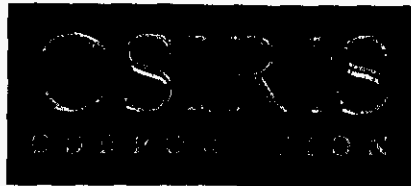

The Commission's Division of Administration forwarded to me for handling a copy of your May 8 letter. You returned the 1999 Regulatory Assessment Fee (RAF) return and advised that all assets had been sold to First Call Communications, Inc.

In Docket No. 990764-TI, Order No. PSC-99-1511-PAA-TI, which was issued on August 3, 1999, canceled your IXC certificate with an effective date of June 3, 1999, the date the Commission received the company's request for cancellation. The Order stated in part:

U.S. Osiris shall return its certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for 1999 will be mailed to U.S. Osiris. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice for 1999 shall relieve U.S. Osiris from its obligation to pay RAFs for 1999.

What this means is that U.S. Osiris is responsible for the final 1999 RAFs payment. The fee was due January 31, 2000; therefore, statutory penalty and interest charges also apply. If U.S. Osiris owes the minimum amount, the past due charges are \$62.00 (\$50.00 fee, \$10.00 penalty, \$2.00 interest) if your check is mailed in May. If your check is mailed in June, the amount increases to \$65.00 (\$50.00 fee, \$12.50 penalty, \$2.50 interest).
