**BELLSOUTH TELECOMMUNICATIONS, INC.'S
POST-HEARING MOTION TO STRIKE**

During the course of the hearing on June 13, 2000, Intermedia Communications, Inc. ("ICI") attempted to testify on matters outside of the pre-filed Direct and Rebuttal testimony submitted in this proceeding. In summarizing her Rebuttal testimony, ICI witness Gold attempted to explain ICI's signing the Amendment to the Interconnection Agreement as the result of some "conspiracy theory" on the part of BellSouth Telecommunications, Inc. ("BellSouth") at the Norcross access tandem in Atlanta, Georgia. (TR. 282) On cross-examination, however, ICI witness Gold admitted that her Rebuttal testimony did not mention this "conspiracy theory." (TR. 296) Thus, in accordance with the directive of the Commission Hearing Panel, (TR. 297-298) BellSouth submits this Post-Hearing Motion to Strike and respectfully requests that page 282, lines 22-25 of the Hearing Transcript be stricken from the record.
