Renewal of Joint Motion for Continuance of Hearing

On June 7, 2000, Sprint-Florida, Incorporated (Sprint) and the Office of the Public Counsel (OPC) (collectively, the Parties) filed a Joint Motion requesting the Commission to continue the hearing and to suspend all testimony filing pending establishment of new hearing dates. On June 9, 2000, Citizens withdrew the joint motion.

Based on recent events, the parties now both believe that their limited resources are best directed to resolving their differences, rather than on preparing for litigation that may not be necessary. Given adequate time, Sprint and OPC hope to achieve a solution that best benefits the public, without the time and expense of a hearing.

For these reasons, Sprint and OPC again ask that the Commission suspend the filing of all remaining testimony in this case and hold a scheduling conference to consider new hearing dates.


