Dear Mr. Smith:

This is in response to your recent letter in which you requested voluntary cancellation of your pay telephone certificate. I cannot recommend voluntary cancellation of a certificate when there is an outstanding balance of regulatory assessment fees (RAFs). In this case, our records show that you paid the 1996 fee on January 31, 1997. The 1996 fee was due January 30, 1997, therefore, penalty and interest charges of \$3.00 (\$2.50 penalty and \$.50 interest) apply. In addition, until the Commission is notified in writing that a company wishes to cancel its certificate, the RAF is due on that certificate if the certificate is active for any day during a calendar year. This means that not only does the 1996 penalty and interest have to be paid before the Commission can grant you a voluntary cancellation, but that you are also responsible for the 2000 RAF since the Commission was not notified until March 31, 2000.

I am enclosing a copy of Rule 25-24.514, F.A.C., which explains how to request voluntary cancellation. The company would need to first pay the past due amount, and then write the Commission another letter advising when the 2000 RAF fee of \$50.00 will be paid. Or, you have the option of going ahead and paying the 2000 fee, even though it is not due until January 30, 2001, when you pay the 1996 penalty and interest charges. Please respond in writing by April 20, 2000, and let me know how you wish to proceed. A 2000 RAF form is enclosed.
