Dear Mr. Socarras:

The Commission's Division of Administration just recently forwarded a copy of your 1999 regulatory assessment fee form, which was received by the Commission on February 11, 2000. You wrote on the form "Business sold." This appears to be a request for cancellation of your pay telephone certificate. Your Certificate No. 2430 became active February 13, 1990 and we received your written request for cancellation on February 11, 2000, therefore, the Commission can make the effective date of the cancellation February 11, 2000. However, you must first pay the 1999 regulatory assessment fee and either pay the 2000 fee or provide a date certain that it will be paid.

Rule 25-4.0161, Florida Administrative Code, provides that if a certificate is active for any day during a calendar year, the regulatory assessment fee is applicable even if no business was ever conducted. The amount past due is \$65.50, if your check is postmarked in July, and the amount for the 2000 fee is the minimum \$50.00. As soon as we receive your check for the correct amount, we will proceed with opening a docket to cancel your certificate.
