

JOINT MOTION FOR CONTINUANCE OF THE SCHEDULE

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), and The Office of the Public Counsel, ("OPC") (collectively, the "Parties"), hereby file this Joint Motion requesting modification of the testimony and possibly other scheduled dates in this case. The purpose of this extension is to give the Parties an opportunity to resolve the issues in this case.

While the Parties continue to work diligently toward a resolution, it appears that more time will be needed. BellSouth and OPC thus ask the Commission to continue the testimony filing dates in this docket, and hold a scheduling conference to determine whether other dates should be changed. At this time, the Parties believe that their limited resources are best directed to resolving their differences, rather than on preparing for filing testimony that may not be necessary. Given adequate time, BellSouth and OPC hope to achieve a solution that best benefits the public.
