Dear Mr. Chambers:

This is in response to your recent letter in which you requested voluntary cancellation of your pay telephone certificate. I cannot recommend voluntary cancellation of a certificate when there is an outstanding balance of regulatory assessment fees (RAFs). In this case, our records show that the company did not pay 1997 and 1999 fees, plus accrued penalty and interest charges. As information, until the Commission is notified in writing that a company wishes to cancel its certificate, the RAF is due on that certificate if the certificate is active for any day during a calendar year. This means that not only are the 1997 and 1999 RAFs past due, but that you are also responsible for the 2000 RAF since the Commission was not notified until April 5, 2000.

I am enclosing a copy of Rule 25-24.514, F.A.C., which explains how to request voluntary cancellation. The company would need to first pay the past due amount in full, and then write the Commission another letter advising when the 2000 RAF fee will be paid.

# 25-24.514 Cancellation of a Certificate.

(1) The Commission may cancel a company's certificate for any of the following reasons:

- (a) Violation of the terms and conditions under which the authority was originally granted;
- (b) Violation of Commission rules or orders;
- (c) Violation of Florida Statutes; or,
- (d) Failure to provide service for a period of six (6) months.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.

(a) Statement of intent and date to pay Regulatory Assessment Fee.

(b) Statement of why the certificate is proposed to be cancelled.

(3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
