Dear Ms. Bayo:

In response to a discussion with Mr. Thomas E. Williams, III, of the Florida Public Service Commission's ("Commission") Division of Regulatory Oversight, Looking Glass Networks, Inc. ("LGN") hereby requests withdrawal of its price list, which is currently associated with the above-referenced application. As stated in its application, LGN will initially provide non-switched dedicated and private line, high capacity fiber optic transmission capacity and access services, primarily to other carriers. Pursuant to the discussion with Mr. Williams, a price list is required only if LGN intends to provide voice services to end-user customers. Accordingly, LGN respectfully requests the withdrawal of its price list.

At such time as LGN begins to provide voice services in the future, LGN will promptly submit a price list, describing basic service, service quality, 911 service, and telecommunications relay service, as required by Commission's Rule 25-24.825. It is LGN's understanding that this withdrawal will not affect the Commission's approval of its Application for authority to provide Alternative Local Exchange Telecommunications Services.


