BELLSOUTH TELECOMMUNICATIONS, INC.'s REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. ("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request for Specified Confidential Classification for its response to the Review of Numbering Resources pursuant to Florida Public Service Commission ("Commission") Order No. PSC-00-0543-PAA-TP.

- 1. In a Memorandum dated July 10, 2000, the Staff of the Florida Public Service Commission ("Staff") stated it would conduct an on-site review of BellSouth's numbering procedures and numbering inventory levels to access compliance with Commission Order No. PSC-00-0543-PAA-TP in Docket No. 981444-TP. A Notice of Intent was filed on August 10, 2000, along with copies of requested documents.
- 2. The information in BellSouth's response to Staff's request contains competitive business and vendor specific information. This information is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes, Sections 364.183 and 364.24.
- 3. Attachment "A" to BellSouth's Request for Specified Confidential Classification contains an explanation of the proprietary information along with a

list that identifies the location of the information designated by BellSouth as confidential.

- 4. Attachment "B" to BellSouth's Request for Specified Confidential Classification contains two copies of the documents with the confidential information redacted.
- 5. Attachment "C" to BellSouth's Request for Specified Confidential Classification is a sealed envelope containing one copy of the documents including those portions that are confidential and proprietary.
- 6. The information provided in BellSouth's response to Staff's request contains competitive business and vendor specific information. A more specific description of this information is detailed in Attachment A. Public disclosure of this information would provide competitors with an unfair advantage in future negotiations. This same information on competitors is not available to BellSouth. The information discussed in this Request for Confidential Classification is valuable and BellSouth strives to keep it secret. Therefore, such information should be classified as customer proprietary information and proprietary, confidential business information pursuant to Section 364.24 and Section 364.183(3)(e), Florida Statutes. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.
- 7. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.

8. The original of this Request was filed today with the Division of Records and Reporting and a copy has been served on the Parties.

WHEREFORE, based on the foregoing, BellSouth respectfully requests that the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.

Explanation of Proprietary Information

- 1. This information constitutes trade secrets that relate to the competitive business of BellSouth. The release of this information would potentially demise BellSouth in that it would allow the competition to have free access to intellectual property which was developed at significant expense to BellSouth. Competitors would then have an advantage in bidding for such business since they would have few, if any, expenses such as market research and market development to recover, and would bid below BellSouth's cost level. Accordingly, this information is entitled to confidential classification pursuant to Florida Statutes Section 364.183(3)(a) and (e).
- 2. This information contains vendor specific information negotiated by BellSouth. Public disclosure of this information would impair BellSouth's ability to contract for goods and services on favorable terms. This information is valuable, it is used by BellSouth in conducting its business and BellSouth strives to keep it secret. Therefore, such information is a trade secret which should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(d), Florida Statutes.
- 3. This information is employee personnel information unrelated to qualifications or responsibilities. This information is expressly identified in Section 364.183(3)(f), Florida Statutes, as proprietary confidential business information.
