By letter dated August 21, 2000, Verizon Florida Inc. (f/k/a GTE Florida Incorporated) filed a Notice of the adoption of the Interconnection, Unbundling, Collocation, and Resale Agreement entered into between GTE Florida Incorporated and DIECA Communications, Inc. d/b/a Covad Communications Company approved by the Commission by Order No. PSC-99-1200-FOF-TP issued June 14, 1999. PurePacket Communications of the South, Inc. is adopting the agreement and all amendments, approved by the Commission as of the date of issuance of the Order, as provided by Section 252(i) of the Telecommunications Act of 1996. The Companies shall be required to file with the Commission any amendments to the adopted agreement approved after the issuance of this Order.

As outlined in Chapter 2.07, Section C.16 of the Administrative Procedures Manual, our review results in our recommendation that the adoption of said agreement and all amendments, approved by the Commission as of the date of issuance of the Order, by PurePacket Communications of the South, Inc. and Verizon Florida Inc. (f/k/a GTE Florida Incorporated) should be approved; an administrative order be issued; and the docket be closed.
