Dear Sirs:

Please consider this letter as my request for a tariff filing to initiate a late payment charge for customers who are consistently late with their payments. Our tariff allows 20 days for the payments for water and wastewater services which I believe is a sufficient amount of time for customers to remit their payments. However, I can easily demonstrate that 02% of our customers consistently pay their water and wastewater bills after the due date because there has never been a penalty for payment after the due date except in the event that service is actually discontinued. we would like to impose a \$ 4.00 late payment penalty for for customers who pay their bills after the 20-day allowance in our tariff. We believe those late payers, who are the cost-causers, should absorb the costs involved with collections rather than the general body of ratepayers who pay on time.

We are a very small utility which needs the monthly cash flow to properly maintain the water and wastewater systems. I am attaching a proposed tariff sheet reflecting the new late payment charge. If you have any questions, Please contact me. Thank You

MISCELLANEOUS SERVICE CHARGES

The company may charge the following miscellaneous service charges in accordance with the terms state herein. If both water and wastewater services are provided, only a single charge is appropriate unless circumstances beyond the control of the Company requires multiple actions.

INITIAL CONNECTION - This charge would be levied for service initiation at a location where service did not exist previously.

NORMAL RECONNECTION - This charge would be levied for transfer of service to a new customer account at a previously served location or reconnection of service subsequent to a customer requested disconnection.

VIOLATION RECONNECTION - This charge would be levied prior to reconnection of an existing customer after disconnection of service for cause according to Rule 25-30.320(2), Florida Administrative Code, including a delinquency in bill payment.

PREMISES VISIT CHARGE (IN LIEU OF DISCONNECTION) - This charge would be levied when a service representative visits a premises for the purpose of discontinuing service for nonpayment of a due and collectible bill and does not discontinue service because the customer pays the service representative or otherwise makes satisfactory arrangements to pay the bill.
