# PETITION OF THE FLORIDA DIVISION OF CHESAPEAKE UTILITIES CORPORATION FOR APPROVAL OF CONSERVATION COST RECOVERY FACTORS

THE FLORIDA DIVISION OF CHESAPEAKE UTILITIES CORPORATION (the Company), pursuant to Rule 25-17.015, Florida Administrative Code, hereby submits this petition to the Commission for approval of its conservation cost recovery factors listed hereinbelow to be applied to bills rendered for meter readings taken between January 1, 2001 and December 31, 2001. In support hereof, the Company states:

3. The conservation cost recovery factors were calculated in accordance with the methodology which has been previously approved by the Commission. The factors are designed to recover the projected conservation program expenses of the Company for

the period January 1, 2001 through December 31, 2001, adjusted for the net true-up (which includes the estimated conservation true-up for the period January 1, 2000 through December 31, 2000), as well as interest calculated in accordance with the methodology established by the Commission. The calculation of the factors and the supporting documentation are contained in the prepared testimony of Company witness Beverly A. Bauck.

4. The Company projects total conservation program expenses, net of all program revenues, of \$298,501 for the period January 2001 through December 2001. The total net projected true-up is an underrecovery of \$12,990. After adding the projected conservation expenses to the amount of this underrecovery, a total of \$311,491 remains to be recovered during the period January 1, 2001 through December 31, 2001. Dividing this total among the Company's firm rate classes and then dividing this result by the projected firm gas retail sales for the period by rate classification, and expanding for taxes, results in the following conservation adjustment factors for which the Company seeks approval in this petition.
