I am writing in response to Commission's motion to cancel the IXC Certificate for Preferred Carrier Services, Inc. ("PCS") in the above stated docket. PCS does not currently provide long distance service in Florida or anywhere else in the United States; however, PCS does intend to start reselling long distance service in the immediate future. PCS does, however, provide local telephone service throughout the United States, including the State of Florida.

It is because of these facts that our new controller, Mr. Jon Pesnell, assumed that he had complied with the Commission's reporting and fee requirements by completing the ALEC annual report and paying the required regulatory assessment fee ("RAF") associated with the sale of local phone service within the State of Florida. In addition, Mr. Pesnell assumed that PCS was only required to file a single annual report and pay a single RAF based on total telecommunications receipts earned within the State of Florida. PCS has now established a tracking system whereby every state commission's annual fee and reporting requirements, including deadlines, are provided to both the legal and finance departments via company intranet and e-mail updates.

PCS has taken the necessary steps to ensure that it this event does not repeat itself and I am confident that all fees and reporting will be provided to the

Commission on a timely basis in the future. I now ask that the Commission close the above-mentioned Docket and propose a monetary settlement of \$200.00, which would be four (4) times amount of the current RAF.

Also enclosed with this settlement proposal, is PCS' completed 1999 IXC RAF return and a check for \$66.50, which covers the fee, penalties and interest. Once again, I ask that the Commission consider this settlement proposal from PCS and apologize for our oversight in providing the Commission with our 1999 IXC RAF.
