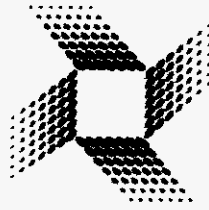

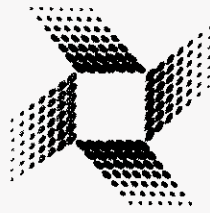

To whom it is relevant,

This letter is a description of the standard course of action taken when a written complaint is received for a Radiant Telecom calling card. Firstly the card's PIN is referenced to see what usage has been made on the card. The next step would be to consider the customer's complaint. In any instance that there is any incorrect billing, all due credits are issued. Additionally the customer would be given a good faith credit to the balance of the card that they wrote in about. The average good faith credit is \$3 - \$5. If there is a situation the that a customer has a complaint with respect to the fees of the calling card then similar steps are taken. The card history is reviewed and the customer's specific complaint is taken into consideration. For instance, if the customer was complaining about the payphone usage fee then an explanation of the fee is given. A credit for all instances of the payphone fee is issued. However it would be explained to the customer that any time in the future the fee would be applied as it was meant to be. A courtesy credit of \$1 - \$3 is issued as well. If a customer calls our customer service department with a complaint regarding one of our calling cards, the same approach is taken. If for instance, the customer insists that they did not know about the connection fee they would be issued back a one time credit for each connection fee assessed up to that point. However it is also explained that the connection fee is inherent to the way the card works and that it would apply to any subsequent use of the card. Having been informed the customer should then understand how the fee is applied. We hope that this explanation of procedure answers any question you might have.

After you have informed me on the compliance issues regarding Radiant's disclaimers, we have gathered the necessary standards from relevant sources and have formed a committee to update our posters and cards with the necessary disclosure. We have contacted our printers and informed them that in all new print jobs, the new disclosures with the appropriate font sizes will be used. The new cards and posters will be printed with the corrected disclosures in the month of October.

The new disclosures for the POS marketing materials will have the following format:

"Access charge (within the US) for each call: Contiguous Domestic ...c, International *\$..., **\$..., ***\$.... International calls to be terminated on cell phones and calls made from Alaska, Hawaii, Puerto Rico, US Virgin Islands, Guam, Saipan, and Canada are subject to additional per minute charges and minutes may be less than those posted on the charts. 1 or ... min. billing increments may apply per state regulation. Additional ...c per call payphone access charge applies as mandated by FCC. Service fee of ...% is waived for one time usage. Maintenance fee of ...c per week applies after the first call. All minutes posted on charts are based on one continuous call. Cards are valid for 6 months from first use. All rates and charges are effective from ... and are subject to change without notice. Carrier services are provided by Radiant Telecom, Inc."
