The above referenced application has been received and reviewed by my staff. This letter is a follow up to the review and subsequent telephone call to you concerning deficiencies which need to be cured and additional clarifications or corrections necessary to process the application.

Deficiencies

- 1. Additional statements: Pursuant to Rule 25-30.037(2)(j), Florida Administrative Code, (F.A.C.), a statement is to be provided which addresses: how the transfer is in the public interest; a summary of the buyer's experience; a showing of the buyer's financial ability to provide service; and that the buyer will fulfill the commitments, obligations and representations of the seller with regard to utility matters. No statement was provided addressing whether the buyer will fulfill the commitments, obligations and representations of the seller with regard to utility matters. Please provide a statement addressing this missing subject area.
- Evidence the utility owns the land: Pursuant to Rule 25-30.037(2)(q), F.A.C., evidence that the utility either owns or has a 99-year lease for the property the utility is located on is to submitted. Exhibit B submitted for this purpose provides a copy of an unrecorded copy a Special Warranty Deed transferring the property to CWS Communities LP. Please provides a copy of the recorded deed.

Transfer without prior Commission approval: Pursuant to Section 367.071, Florida Statute no transfer is to take place without prior Commission approval. This section was modifit effective June 11, 1999, to allow for transfer prior to commission approval if the contract for
