This e-mail is transmitted to express my strong disagreement with the proposed 10-digit overlay for the Martin, St. Lucie, Indian River County area. The overlay would be a short-term solution, providing only band-aid relief, at best.

Other alternatives include utilizing the wealth of unused telephone numbers in the 561 area code bank that are not being used, assigning new prefixes, or choosing a specific geographic section from the proposed overlay area and assigning a new code to only that portion of telephone customers and would provide longer term relief and cause much less inconvenience to the public.

Business and residential customers from areas such as Dade County that have been forced to implement a 10-digit system are less than satisfied with the results.

As a business owner and resident of the Treasure Coast, I encourage the PSC to make every effort to arrive at a long-term solution to this problem, thereby setting an example for other regions of the country that are seeking a viable solution to their phone number "shortage" to follow, rather than adopting the "easy way out" and implementing a 10digit overlay.
