Ms. Bayo':

Please find enclosed a copy of a past-due ALEC Regulatory Assessment Fee Return and the corresponding payment (including penalty and interest).

As you will note from the return, CPU Solutions Holding Corp has generated zero revenues from its Alternative Local Exchange business. As of today's date, CPU Solutions is still in the process of developing its offerings and network. As I'm sure you're aware, compliance is a major challenge to small ALEC's such as ours. Procedures are now in place to ensure that this RAF issue does not trip us up again.

As CPU has generated no ALEC revenues to date (and hence no large RAF), and this docket was initiated due to an honest oversight (not an effort to <u>avoid</u> the RAF), I would like to propose a very modest punitive settlement of \$50. I can understand the PSC's responsibility to collect the RAF and any associated fines and penalties; I would just ask that the PSC take into consideration the unique circumstances surrounding this docket.

Please feel free to contact me as soon as possible with a response to this settlement offer. It is my desire to put this issue behind us so we can both move on to more productive endeavors.
