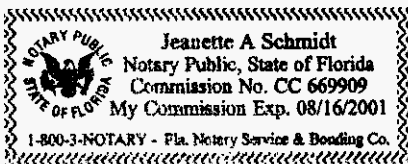

**PURPOSE AND PROCEDURE**
