2.6 Billing and Payment for Service, (Cont'd.)

Billing Dispute 2.6.6

- Any objections to billed charges must be reported to the Company or its billing .1 agent in writing within thirty (30) days of the closing date printed on the invoice or statement issued to the Customer. Disputes may be submitted orally or in writing. Adjustments to Customers' account shall be made to the extent that circumstances exist which reasonably indicate that such changes are appropriate.
- Late payment fees will not be applied during the period when a bill is disputed .2 regardless of the outcome of the dispute.
