ORDER ON IN CAMERA REVIEW CONDUCTED TO DETERMINE THE INFORMATION THAT TAMPA ELECTRIC COMPANY MUST PRODUCE IN RESPONSE TO ALLIED UNIVERSAL CORPORATION'S REQUESTS FOR PRODUCTION OF DOCUMENTS

NOS. 6, 7, AND 8

On January 20, 2000, Allied Universal Corporation and Chemical Formulators, Inc. (Allied) filed a formal complaint against Tampa Electric Company (TECO). The complaint alleges that: 1) TECO violated Sections 366.03, 366.06(2), and 366.07, Florida Statutes, by offering discriminatory rates under its Commercial/Industrial Service Rider (CISR) tariff; and, 2) TECO breached its obligation of good faith under Order No. PSC-98-1081A-FOF-EI. On March 28, 2000, Odyssey Manufacturing Company (Odyssey) requested permission to intervene, and that request was granted on April 18, 2000, in Order No. PSC-00-0762-PCO-EI. Allied and Odyssey manufacture bleach.

On March 10, 2000, TECO submitted a copy of its CISR files on Odyssey and Allied. The files contain documents that are responsive to Allied's Request for Production of Documents (PODs) Nos. 6, 7 and 8. Order No. PSC-00-1171-CFO-EI, issued on June 27, 2000, in this docket, required that TECO create a list of documents from its submittal of March 10, 2000, that it detend responsive to PODs 6-8, and that I review the listed documents, in camera, to determine whether any information in the documents was privileged.

TECO identified responsive documents and identified pages of those documents it deemed privileged. In most cases I agreed with TECO's determination of the documents that were responsive and privileged information. However, in some cases I found additional documents to be responsive, and in some cases I found that less information should be privileged. Thus, the outcome of the *in camera* review is that TECO will have to produce some additional information to Allied.

The results of the *in camera* review are provided in Attachment 1 (POD 6) and Attachment 2 (PODs 7 and 8). Where my findings differed from TECO's, my findings appear in boldface type. This will allow TECO to quickly determine which documents and information must be produced. TECO shall produce all documents in accordance with the instructions on the Attachments. The documents shall be produced within five business days of the issuance of this order.

The legal principles on which my findings are based are provided in Part III.C. of Order No. PSC-00-1171-CFO-EI. That portion of the order discusses the Florida Rules of Civil Procedure and the Commission's rules that apply to granting information confidential and privileged status. In addition, the balancing test that must be used to decide if information is privileged, and an explanation of the factors considered and how they are weighed in the balancing test is provided.

The information deemed privileged in Attachment 1 is primarily information on Odyssey's plant size, plant design and financial status. This information is confidential under Section 366.093, Florida Statutes, because Odyssey treats it as private and Odyssey's ability to compete in its native market would be harmed if the information were available to the public.

Making this information available to Allied through discovery would harm Odyssey's ability to compete in its native market. It would also discourage eligible customers from pursuing a CISR tariff for fear that their ability to compete could be compromised. Ultimately, rate payers could be harmed if potential CISR customers leave TECO's service area. Allied stated on numerous occasions that it did not want this information and has not shown that its need for this type of information outweighs the harm that would result to Odyssey if the information is produced. I find that the harm to Odyssey from production of this information exceeds the

harm to Allied of withholding this information, and the information is therefore privileged.

The information deemed privileged in Attachment 2 is primarily information on Allied's plant size, plant design and financial status. This information is confidential under Section 366.093, Florida Statutes, because Allied treats it as private and disclosure of this information to the public would harm Allied's ability to compete in its native market. It is privileged because requiring it to be produced would discourage eligible customers from pursuing a CISR tariff. Ultimately, rate payers could be harmed if potential CISR customers leave TECO's service area. Neither TECO nor Odyssey has requested this information or explained how they would be harmed if it is not produced. I find that the harm to Allied from production outweighs the harm to TECO or Odyssey from withholding production.

Based on the foregoing, it is

ORDERED that Tampa Electric Company shall produce to Allied Universal Corporation, within five business days of the issuance of this order, the information listed in Attachments 1 and 2 to this Order.

administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
