Issue #3: What is the total purchased gas adjustment true-up amount to be collected during the period of January 2001 through December 2001?


SJNG's Position: \$25,619 underrecovery

SJNG's Position: 82.100 recovery (cap) factor

Issue #5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

SJNG's Position: The effective date for the new purchased gas adjustment charge should be January 1, 2001.
