I have prepared this project update letter so that you may use it in your preparation of your monthly report to the FPSC concerning this project.

Since your last report to the FPSC, dated September 21<sup>st</sup>, we have continued our efforts in developing the detailed pilot study work plan, equipment lists, laboratory services needs lists and master project schedule.


Moss-Kelly, Inc., who represents the majority of the equipment manufacturers who will supply pilot testing equipment for this project, has been working diligently with our firm to refine the equipment layout for the pilot testing unit. They are also working with our firm and the manufacturer's to develop budget cost estimates for the equipment that will be needed.

I met with Yanisa Angulo (Permitting Section) of the FDEP in Tampa to begin discussing the pilot study project in general and to begin working with her to gain preliminary acceptance for our pilot study work plan. This is an important element of the project as any design oriented data resulting from the project will need to be approved by them before any subsequent future water plant construction, if any, based on this data can begin.

By the next report, scheduled to be prepared at the end of November, we hope to be ready to provide you with detailed project work plans, pilot study unit layout design and cost estimates.
