DISCUSSION OF ISSUES

ISSUE 1: Should the Commission suspend Florida Power & Light Company's (FPL) proposed tariff filed as part of FPL's petition for approval of a Demand-Side Management (DSM) Adjustment Rider?

RECOMMENDATION: Yes. The Commission should suspend FPL's proposed tariff revision. (Colson)

STAFF ANALYSIS: Pursuant to Rule 25-17.015, Florida Administrative Code, FPL filed a petition on September 26, 2000, for approval of a DSM Adjustment Rider. Section 366.06(3), Florida Statutes, authorizes the Commission to withhold consent to the operation of all or any portion of a new rate schedule, delivering to the utility requesting such increase, within 60 days, a reason or written statement of good cause, consistent with the requirement of Section 366.06(3), Florida Statutes. Staff recommends that the proposed tariff revision be suspended to allow sufficient time to
