<u>REQUEST FOR CONFIDENTIAL CLASSIFICATION</u>

Florida Power Corporation (Florida Power or the Company), pursuant to Section 366.093, F.S., and Rule 25-22.006, F.A.C., hereby requests confidential classification of highlighted portions of the seventeen-page document contained in the sealed envelope enclosed with this request (the Document). Two public copies of the Document, with the confidential information redacted, are also enclosed. The Document was requested by Staff in connection with its Second Set of Interrogatories to Florida Power Corporation, Number 41, propounded upon the Company in the subject docket. In support of its request, Florida Power states as follows:

1. The Document contains the names of vendors with which Florida Power has maintained contracts between the dates of August 1, 1999 and October 11, 2000. The Document also contains the value of each contract. Many of these contracts have been established through a competitive bidding process and many of the vendors listed desire to keep the nature of their relationship with Florida Power confidential. The associated contact values contained in the Document

represent negotiated figures which, if publicly disclosed, would inhibit the ability of the Company to obtain the most cost-effective services on behalf of its customers. Under normal circumstances, this information is not distributed to individuals within Florida Power unless there is a business need, and is not provided to anyone outside of the company. Florida Power contends that the highlighted information contained in the Document is commercially sensitive and justifies its protection from disclosure to the Company's competitors and potential vendors.

2. Subsection 366.093(1) provides that any records "found by the commission to be propriety confidential business information shall be kept confidential and shall be exempt from s. 119.07(1) [requiring disclosure under the Public Records Act]." Subsection 366.093(3) states that "Propriety confidential business information includes, but is not limited to: *** (e) information relating to competitive interests, the disclosure of which would the competitive business of the provider of the information." The designated portions of the Document fall within this statutory category and, thus, constitute propriety confidential business information entitled to protection under Section 366.093 and Rule 25-22.006.

3. The designated information for which confidential classification is sought is intended to be and is treated by the Company as private and has not been publicly disclosed.

4. Attachment A hereto contains a justification matrix supporting Florida Power's request for confidential classification of the highlighted information in the Document. The information is identified on a page-by-page, column-by-column basis. WHEREFORE, Florida Power respectfully requests that the highlighted information in the Document contained in the sealed envelope enclosed with this request be classified as confidential for the reasons set forth above and in Attachment A hereto.

| 1-17 | all | 7-9 Contract Value, Amended Amount, and Total Contract Value | Contract Values of various services contracted by Florida Power is sensitive competitive information. Vendors who have provided Florida Power price concessions more favorable than offered to other purchasers will be unwilling to do so in the future if these prices are disclosed. Disclosure of contract values to potential vendors of comparable services in the future would enable such vendors to tailor their bids accordingly and prevent Florida Power from receiving their lowest prices. These effects of disclosure would thus impair the efforts of the Company to contract for goods and services on favorable terms for the benefit of its customers. |
