



### TAMPA ELECTRIC COMPANY'S CORRECTIONS TO PREHEARING STATEMENT

Tampa Electric Company ("Tampa Electric" or "the company"), subsequent to the filing

of its Prehearing Statement on October 26, 2000 has determined that the following corrections

should be made to the company's Prehearing Statement:

1. The second exhibit identified for Tampa Electric (identified as Exhibit (KOZ-1)

in Tampa Electric's Prehearing Statement) should be changed to Exhibit (KOZ-2).

2. The third exhibit identified in Tampa Electric's Prehearing Statement as Exhibit

(KOZ-2) should be corrected to read Exhibit (KOZ-3).

3. Tampa Electric's position on Issue 1 should be corrected to read as follows:

The appropriate final environmental cost recovery true-up amount for this period is an overrecovery of \$281,469. (Witness: Zwolak).

(This change reflects the proper use of new depreciation rates approved in Commission Order No. PSC-00-0603-PAA-EI, issued in Docket No. 990529-EI on March 29, 2000. The new depreciation rates were effective January 1, 1999 and were not used in preparing the initial true-up calculation.)

4. Tampa Electric's position on Issue 2 should be corrected to read as follows:

The estimated environmental cost recovery true-up amount for the period is an underrecovery of \$3,071,714. (Witness: Zwolak)

(This change reflects the new depreciation rates effective January 1, 1999 and also implements the provision in the depreciation order authorizing accelerated depreciation in connection with the Gannon re-powering project.)

5. Tampa Electric's position on Issue 3 should be corrected as follows:

The total environmental cost recovery true-up amount to be collected during this period is an underrecovery of \$2,790,245. (Witness: Zwolak)

(This change reflects the new depreciation rates effective January 1, 1999 and also implements the provision in the depreciation order authorizing accelerated depreciation in connection with the Gannon re-powering project.)

6. Tampa Electric's position on Issue 4 should be modified to read as follows:

The appropriate amount is \$28,081,761. (Witnesses: Zwolak, Martin, Nelson)

(This change reflects the new depreciation rates effective January 1, 1999 and also implements the provision in the depreciation order authorizing accelerated depreciation in connection with the Gannon re-powering project.)

7. Tampa Electric's position on Issue 8 should be corrected to read as follows:

The appropriate factors are:
