

Dear Ms. Cibula:

Due to the information that you supplied to me via telephone on November 1, 2000 that United Water has amended the above referenced applications to serve only the Lighthouse Pointe, a.k.a. Amelia Island Ventures, Inc., development, we withdraw our objection. Our withdrawal is based on the understanding that no other residence now or in the future will be required to tie into this sewer system.

It is a real tragedy to watch what is happening to our area due to the greed of big developers who are only interested in making money. What was once a beautiful rural area is now becoming just one more over populated, undesirable place to live. The high-density development is the real problem in Florida. The beauty that drew people here in the first place is quickly being replaced by too many supposedly "planned urban developments" which destroy the integrity of our communities. It is hard to understand why our elected officials who are supposed to represent the people who elected them, end up voting in favor of outside developers whose only purpose is personal gain. It was our understanding that elected officials who are in real estate sales themselves were prohibited from voting on applications that would give developers permission for developments that the officials would have opportunity to also gain from. That is not the case in our county.
