

NOTICE OF APPLICATION FOR AN AMENDMENT OF CERTIFICATE
AND EXTENSION OF SERVICE AREA

October 30, 2000

AQUASOURCE UTILITY, INC., 200 Corporate Center Drive, Suite 300, Coraopolis, PA 15108, pursuant to Section 367.045, Florida Statutes, hereby notices its intent to apply to the Florida Public Service Commission for an extension of its service area to provide water service to the property located in Highlands County, Florida, described below:

Township 35 South, Range 28 East: The southeast 1/4 of the southeast 1/4 of Section 28, the southwest 1/4 of Section 27, the east 1/2 of Section 31, all of Sections 32, the south 1/2 of the southeast 1/4 of Section 33, the northwest 1/4 of Section 34, all in Township 35 South, Range 29 East, less the westerly 305' of the northwest 1/4 of the southwest 1/4 of Section 27, Township 35 South, Range 29 East.
