Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated October 12, 2000, McLeodUSA Incorporated (McLeodUSA), CapRock Telecommunications Corp. (CapRock), and Telecommunications Services, Inc. (McLeodUSA Telecommunications) filed with this Commission an application for approval of transfer of control whereby McLeodUSA will acquire control of CapRock, a wholly owned subsidiary of CapRock Communications Corp., and CapRock's assets will be transferred to McLeodUSA's subsidiary, McLeodUSA Telecommunications. CapRock is the holder of Interexchange Telecommunications (IXC) Certificate McLeodUSA Telecommunications is the holder of IXC No. 5243. Certificate No. 4807. CapRock and McLeodUSA Telecommunications have stated that the transaction will be virtually transparent to their customers in Florida and it will not affect the services being provided.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of McLeodUSA, CapRock, and McLeodUSA Telecommunications, and find it reasonable to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. Our decision does not address the potential impact of the transfer on the competitive market in Florida, or on the companies' or their competitors' interests. We emphasize, however, that our approval of the Petition pursuant to our authority under Section 364.33, Florida Statutes, does not preclude us from addressing any of our concerns that may arise regarding this transaction to the appropriate federal or state agencies.

Based on the foregoing, it is,
