At the November 7, 2000, Agenda Conference, the Commission approved the interconnection, unbundling, resale, and collocation agreement between BellSouth Telecommunications, Inc. (BellSouth) and PointeCom, Inc. d/b/a Telscape Telecommunications, Inc. On November 27, 2000, however, BellSouth filed for withdrawal of the original request for approval of the agreement. Staff will be filing a recommendation for the December 19, 2000, Agenda Conference to address the company's request for withdrawal.

For the reasons described above, the Order approving the interconnection, unbundling, resale, and collocation agreement, due to be filed on November 27, 2000, will not be issued. Upon the disposition of this matter on the December 19th Agenda Conference, an order consistent with the Commission's decision will be issued.
