### Summary

Windstream Utilities Inc., has applied to the Public Service Commission for an amendment to its Water Certificate. The proposed expansion to their service territory is the addition of 18 rural single family home sites adjacent to the Carriage Hills subdivision (see Attached Map 1). Windstream Utilities will also be upgrading its system to include an additional 8" well with a 10,000 gallon storage tank to serve the proposed expansion.

#### **Background**

The Carriage Hills subdivision which is adjacent to the proposed service territory expansion is within the Windstream plant service area. The Windstream Utilities Company has been incorporated since 1984 and operates systems in both Citrus and Marion Counties.


#### Staff Review of the Application

The proposed service territory does not appear to conflict with any other established water service area in Marion County and the proposed service territory expansion is consistent with the Marion County comprehensive plan. Marion County planning staff said that the County had no concerns regarding the proposed utilities application.
