On December 12, 2000, BellSouth Telecommunications, Inc. ("BellSouth") filed its Notice of Intent to Request Specified Confidential Classification for information contained in its response to Staff's Interrogatory No. 6, which contains confidential business information that is considered proprietary to Sprint Spectrum L.P. d/b/a Sprint PCS ("Sprint PCS"). As noted in BellSouth's Notice, the information contained in that response is from Sprint PCS' cost study (Document No. 07649-00). On August 30, 2000, the Commission issued its Order No. PSC-00-1564-CFO-TP in which it granted confidential treatment of Document No. 07649-00, including the information contained in the aforementioned response.

In view of the foregoing, it would serve no purpose for either BellSouth or Sprint PCS to again request confidential classification for the material contained in Sprint PCS' cost study. Accordingly, please maintain the confidentiality of that material to the same extent and in the same manner as the Commission is maintaining that information included in Document No. 07649-00.
