ORDER APPROVING ADOPTION OF INTERIM INTERCONNECTION, UNBUNDLING, AND RESALE AGREEMENT

BY THE COMMISSION:

On October 20, 2000, Verizon Florida Inc. (f/k/a GTE Florida Incorporated) (Verizon Florida) and SBC Telecom Inc. d/b/a SBC National Inc. (SBC National) filed a notice of adoption in its entirety of the interim interconnection, unbundling, and resale agreement entered into and between GTE Florida Incorporated (n/k/a Verizon Florida Inc.) and AT&T Communications of the Southern States, Inc. d/b/a AT&T, pursuant to 47 U.S.C. §252(i) of the Telecommunications Act of 1996 (the Act). This agreement was approved by the Commission by Order No. PSC-00-1776-FOF-TP, issued on September 28, 2000, and is incorporated by reference herein. A copy of the agreement may be obtained by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(i) requires that a local exchange carrier shall make available any interconnection, service, or network element provided under an

agreement approved by the state commission to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety. Further, Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The adoption of this agreement shall be effective on the date of issuance of this Order and will expire on the date specified in the agreement. This agreement governs the relationship between the companies regarding local interconnection and the exchange of traffic pursuant to 47 U.S.C. § 251. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the agreement.

Upon review of the proposed adoption, we find that it complies with the Act; thus, we hereby approve it. Verizon Florida and SBC National are also required to file any subsequent supplements or modifications to this agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Verizon Florida Inc. (f/k/a GTE Florida Incorporated) and SBC Telecom Inc. d/b/a SBC National Inc.'s adoption in its entirety of GTE Florida Incorporated (n/k/a Verizon Florida Inc.) and AT&T Communications of the Southern States, Inc. d/b/a AT&T's interim interconnection, unbundling, and resale agreement, incorporated by reference in this Order, is hereby approved. A copy of the agreement may be obtained as specified in the body of this Order. It is further.

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket is hereby closed.
