We received your letter dated December 15, 2000 from Mr. Don Killen and would like to apologize for the confusion, but until we asked Don for his copy of the October 24th letter, we were unaware that the commission wanted anything more than our payment on the 1999 RAF return.

ADIS sold its assets to a company called Vertecall Communications, Ltd. in June of 2000 and Mr. Killen became an employee of that company. It was our understanding that Vertecall Communications would file a separate application with the Public Service Commission and notify ADIS when the application was approved so that we could cancel the license. Don Killen provided us with the 1999 tax form without your letter in late October 2000 and we made the payment as listed on the form. On December 1, 2000, Vertecall Communications, Ltd. filed for protection under Chapter 7 of the Bankruptcy Act apparently never having filed an application with the commission. As a result, Mr. Killen forwarded your letter and the Public Service Commission file to us on December 19th.

Now that we have both of your letters, we would like to voluntarily cancel our license effective immediately. As was mentioned in the October 24th letter, we acknowledge that we will owe the minimum regulatory fee for the year 2000 since we did not provide any billable services. We will be glad to pay the fee if you will notify us whether a printed form will be provided to us in January 2001 or whether we can use a copy of the return we filed previously to make the 2000 tax payment. We ask that you waive the fine of \$500 for the 1999 filing in light of the circumstances listed above and the fact that we have voluntarily elected to cancel the license.
