Dear Mr. Leonette:

As you are probably aware, on December 9th, Mr. Fred Esposito returned my call requesting a metes and bounds description of the unserved territory in Rivers Edge Subdivision for noticing the Commission's intent to initiate proceedings for a possible deletion from Hunter Creek Utilities, LLC's (Hunter Creek's or utility's) service territory. Mr. Esposito informed me that a survey was being conducted at that time but would not be concluded until some time late in January 2000. Coincidentally, Mr. Esposito believed the plant improvements would be installed by that time as well.

Since Order No. PSC-99-2380-PCO-WS, issued December 6, 1999, had ordered that notice be published in the Florida Administrative Weekly (FAW), staff had no recourse but to estimate unserved territory using quarter section descriptions from maps and information previously provided by the utility. The resulting notice was published in the FAW on December 30, 1999. The 30 day comment period will elapse at the end of January. Attached is a copy of Order No. PSC-99-2380-PCO-WS and the FAW notice for your records.

On January 3, 2000, staff was informed by the Florida Department of Environmental Protection (FDEP) that Hunter Creek's construction permit for the plant improvements was approved effective December 29, 1999. Hopefully this means that the plant will, indeed, be installed on the before the end of January as Mr. Esposito had predicted. FDEP will inform staff when the requirements of its Consent Order have been met. Until then, however, staff must continue with the proceedings for possible deletion of territory.
