Hi. Sorry, just getting to my E-Mail now.

Docket No. 990253-WU is a transfer of Certificate No. 428-W from Inglewood Water System (a corporation) to Lonnie and Royanna Parnell (a sole proprietorship). A new company code should be established for the sole proprietorship "Lonnie and Royanna Parnell." And, once the order is fixed, Certificate No. 428-W should be transferred to the name of Lonnie and Royanna Parnell. So, yes, in Docket No. 990253-WU, the name on Certificate No. 428-W is changing to Lonnie and Royanna Parnell. However, we don't include a name change in the docket title of transfers of certificates.

When a certificate transfers from one company entity to another -- be they corporations, limited partnerships, or sole proprietors, the name on the certificate is automatically changed to reflect the transferee's name, unless specifically petitioned otherwise. When the transfer is that of majority control -- which Docket No. 990253-WU is not -- then the name on the certificate remains unchanged, unless petitioned otherwise. That is because only the people who have controlling interest within the utility are changing. The utility, itself, is not being transferred from one company to another.

Now that Lonnie and Royanna Parnell have finally formed a corporate identity, an application was sent last Friday for a change in name on Certificate No. 428-W from Lonnie and Royanna Parnell to Par Utilities, Inc. This will be handled as a new docket. In a

name change docket, the name on the certificate will obviously change, but the company code will remain the same because there is no new owner -- just a new name for the existing owner. That is why I was concerned that no company code had been established for the sole proprietorship known as Lonnie and Royanna Parnell.

It is very unusual for us to have sole proprietors as the utility owner. Almost all utility owners know to incorporate to protect their personal assets. However, we have a few instances where sole proprietors are the utility owners. Example: Keith and Clara Starkey, WS-753.
