Dear Mr. Thompson:

According to our records, Spruce Creek South Utilities, Inc. failed to timely file its 1999 Annual Report by March 31, 2000 or by its requested extension date of May 31, 2000 as required by Rule 25-30.110(3), Florida Administrative Code (FAC). Rule 25-30.110(7), FAC, sets penalties for noncompliance with the annual report requirement. The applicable penalty for a Class B utility is \$13.50 per day and is based on the number of calendar days elapsed from the due date until the date of filing. The due date in this case was May 31, 2000. Therefore, it is imperative that the utility promptly file the 1999 annual report as well as make a check payable in the amount of the penalty to the Florida Public Service Commission. The payment of the penalty should be mailed to: Bureau of Fiscal Services, Florida Public Service Commission, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, ATTN: Evelyn Sewell.
