

(United Water) petitioned for recovery of prior Other Postretirement Benefit (OPEB) expenses, even though the utility had not complied with Rule 25-14.012, Florida Administrative Code, by seeking timely recovery or deferral of the expenses. In the alternative, United Water sought a waiver or variance from Rule 25-14.012 pursuant to Section 120.542, Florida Statutes. The Commission denied the petition, in part, because recovery would result in retroactive ratemaking and the utility failed to meet the statutory requirements for obtaining a rule variance or waiver.
