TAMPA ELECTRIC COMPANY'S MOTION FOR EXPEDITED RESPONSES TO SECOND REQUEST FOR PRODUCTION OF DOCUMENTS (NOS. 13-24) TO ALLIED UNIVERSAL CORPORATION AND CHEMICAL FORMULATORS, INC.
