NOTICE OF PROPOSED AGENCY ACTION ORDER CANCELING ALTERNATIVE LOCAL EXCHANGE TELECOMMUNICATIONS CERTIFICATE AND INTEREXCHANGE TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

BroadSpan Communications, Inc. d/b/a Primary Network Communications, Inc. (BroadSpan), holder of Alternative Local Exchange Telecommunications Certificate (ALEC) of Public Convenience and Necessity No. 7445, and Interexchange Telecommunications Certificate (IXC) of Public Convenience and Necessity No. 7376 has requested the cancellation of ALEC Certificate No. 7445 and IXC Certificate No. 7376. BroadSpan has complied with the provision of Rules 25-24.474(2) and 25-24.820(2), Florida Administrative Code, by providing adequate notice in

writing of its request for cancellation of its ALEC and IXC certificates and by submitting its Regulatory Assessment Fees (RAFs) for the year 1999. Accordingly, we find it appropriate to cancel ALEC Certificate No. 7445, and IXC Certificate No. 7376, effective December 19, 2000. BroadSpan shall return to this Commission the Orders granting authority to provide ALEC and IXC services.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAFs of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2000 has been mailed to BroadSpan. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2000 shall relieve BroadSpan from its obligation to pay RAFs for the year 2000.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that BroadSpan Communications, Inc. d/b/a Primary Network Communications, Inc. 's Certificate No. 7445 to provide Alternative Local Exchange Telecommunications services and Certificate No. 7376 to provide Interexchange Telecommunications services is hereby canceled, effective December 19, 2000. It is further

ORDERED that BroadSpan Communications, Inc. d/b/a Primary Network Communications, Inc. shall return to this Commission the Orders granting authority to provide Alternative Local Exchange Telecommunications services and Interexchange Telecommunications services, and remit Regulatory Assessment Fees for the year 2000. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule' 28-106.201, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto.
