Re: Notice of Corporate Name Change for Advanced TelCom Group, Inc.

Dear Blanco Bayo:

This letter serves to clarify the corporate name change for the company known as "Advanced TelCom Group, Inc." Advanced TelCom Group, Inc. has a certificate of authority in this name in the state of Florida to operate as an interexchange and competitive local exchange telecommunications services company.

Advanced TelCom Group, Inc. received approval from the Secretary of State in Florida, on December 11, 2000, to change its name. We previously submitted a letter, on March 19, 2001, notifying the Florida Public Service Commission ("Commission") of a corporate name change from "Advanced TelCom Group, Inc." to "Advanced TelCom, Inc." However, pursuant to discussion with Ms. Toni McCoy, I understand that the company is actually registered and authorized to operate in the state of Florida only as "Advanced TelCom of Delaware, Inc." Thus, this letter serves to notify the Commission of the true and proper name change. Although the company typically operates outside of Florida as Advanced TelCom, Inc., this name is not available in Florida. The Florida Secretary of State's database does cross-reference the two names, "Advanced TelCom, Inc." and "Advanced TelCom of Delaware, Inc." Copies of the certificates of approval from the Secretary of State were previously submitted to the Commission.

The name change is the only corporate name change to report. No other changes to either the corporate or financial organization of the company have occurred.
