Covad Communications Company's Motion for Extension of Time

DIECA Communications, Inc. d/b/a Covad Communications Company (Covad), pursuant to rule 28-106.204, Florida Administrative Code, moves for an extension of time for the filing of rebuttal testimony and prehearing statements in this case until May 25, 2001. As grounds therefor, Covad states:

1. The current procedural schedule calls for rebuttal testimony by both parties to be filed on May 14, 2001. The Prehearing Conference is scheduled for June 11, 2001. The hearing in this case is scheduled for June 27-29.

2. Direct testimony, including line sharing and collocation cost studies, were filed in this case on April 23, giving Covad only three weeks to prepare rebuttal testimony. Given the number of witnesses and the number of issues involved in this matter, Covad requires additional time to analyze the testimony and file appropriate rebuttal testimony. Therefore, Covad requests an extension of time until May 25 to file its rebuttal testimony. The same due date for rebuttal testimony would be applicable to BellSouth.
