This letter is being sent to propose a settlement offer regarding the Regulatory Assessment Fee Return for the year ended December 31, 2000 on behalf of StormTel, Inc.

In response to Docket No. 010913, recently opened by the Commission, StormTel, Inc. provides the following information:

## **Proposed Settlement**

<u>Proposed Settlement:</u> The Company offers the Florida Public Service Commission (FPSC) a pledge to file all Regulatory Assessment Fee Returns by the due date and a settlement offer of \$100 to compensate the FPSC for the time spent in opening and tracking this docket. The company has already provided the year end December 31, 2000 Regulatory Assessment Fee Return to the Commission under separate cover as well as any late fees and penalties.

<u>Statement:</u> StormTel, Inc. states that it has taken steps to prevent future late payments of the regulatory assessment fee returns. The company has set up a notification system regarding future filing requirements and filing dates.

Address Change Issues: The Commission, in its letter from Ms. Paula Isler, stated its concern over StormTel, Inc. not providing the Commission with a current address. Attachment I to this settlement offer contains the address change notification submitted to the Commission on June 21, 2001. This revision was received by the Commission on June 22, 2001. The company believes that it did make the proper contact with the Commission once the company had in fact finalized the relocation to its current address.
