BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, files this Notice of Intent to Request Specified Confidential Classification and states:

1. In Order No. PSC-01-1973-PCO-TL ("Order"), issued October 4, 2001, the Florida Public Service Commission ("Commission") established an expedited process for reviewing the denial of a central office code request by the North American Numbering Plan Administration ("NANPA"). As part of that expedited process, the Order requires any carrier seeking the reversal of a decision by NANPA to deny a request for additional numbering resources to provide the Commission with the following information: (1) the customer's name, address, and telephone number; (2) the utilization thresholds for every switch in that particular rate center where additional numbering resources are sought; and (3) the months-to-exhaust for every switch in that particular rate center where additional numbering resources are sought.
