It is my feeling that the above Utility Company is operating under questionable circumstances. Nobody has read our meter since it was installed, but we are being billed for usage, an amount that is beyond our comprehension.

Some of the homes in the community do not have meters and do not pay for water and sewer. Those of us who are metered are apparently paying for the entire community.

We embarked on a "little or almost no water usage" program. Our lawn has not been irrigated since December, we are doing laundry and washing the car and taking necessary showers at my daughter's home, using the dishwasher only once a week, showering (1 minute showers) only twice a week at home, flushing when very necessary. This is not the way we choose to live. We can't account for the 2000 gallons we are billed for, and for a retired couple on a very limited income, the rates are not in line.

Dear Ms. Koepplinger:

I am writing in response to your March 9, 1999 letter regarding Shangri-La by the Lake Utilities, Inc. (Shangri-La or utility.) On January 22, 1999, the Commission received a formal complaint signed by 55 of Shangri-La's customers. The Commission is currently reviewing the rates and billing practices of the utility in Docket No. 990080-WS, entitled "Complaint and request for hearing by Linda J. McKenna and 54 petitioners regarding unfair rates and charges of Shangri-la by the Lake Utilities, Inc. in Lake County." My staff is scheduled to present a recommendation regarding their findings at the Commission's Agenda Conference on June 29, 1999. We will include your letter for consideration in that docket.

You are correct that some customers are paying based on metered service and some are not. However, let me assure you that the metered customers are not paying the full costs of the utility. The rates charged by the utility were approved by this Commission. The Commission determined the utility's rates taking into consideration the total number of customers in the mobile home park. Consequently, each customer only pays their share of the costs even if some customers are not yet metered. The customers who are not yet metered are still paying for their water and wastewater service through their rent, as you previously paid for your service through your rent. The utility is in the process of installing the meters and converting to metered billing as each tenant's lease comes up for renewal and can be modified to reflect this change. All of the customers will eventually be metered.

Some of Shangri-La's customers previously questioned the quality and accuracy of the water meters installed by the utility. My staff has verified that the meters installed by the utility are a good brand of meters and were new when installed. Meters are tested at the factory prior to installation, therefore, it is unlikely that a new meter would malfunction. However, as part of our investigation,

my staff engineer visited your area in February and was present while several of your neighbor's meters were field tested. All of the meters tested were found to be accurate.

Having ruled out the likelihood of meter failure, some other explanations for your unexpected usage level are: (1) you may have a leak in your house, (2) the utility may have read the meter incorrectly, or (3) you in fact used the water for which you were billed. Many people are unaware of the significant amount of water that can be lost through an undetected leak. If you are not aware of any leaks in your house, there is a quick test you can perform to check for leaks. First, make sure that no water is running inside or outside your house, such as a shower, dishwasher, or garden hose. Then watch your water meter for a few minutes. If the dial is moving even though all of the water is turned off, you have a leak somewhere in the house.

Alternatively, if you believe the utility has made an error in reading your meter, you may likewise read your meter and compare it to the amount of usage for which you are billed. For future reference, the utility plans to read the meters on the 15th of each month to the extent possible. There may be occasions when the meters will be read a day earlier or later than that, such as if the weather is bad or the 15th falls on a weekend. If you so desire, you may read your own meter around that time and compare your reading to the amount billed by the utility.

Because the meter will continue to move as you use water, your reading and the utility's reading will vary unless you read the meter at the exact same time that the utility reads your meter. However, you should still be able to determine if you are being billed for the correct number of gallons. The utility plans to bill for usage by rounding down to the nearest 1,000 gallon level for billing purposes. For example, if your first meter reading was 2,500 gallons, the utility only billed you for the first 2,000 gallons. The remaining 500 gallons will not be billed until the meter reading has reached the next 1,000 gallon increment, which for purposes of this example is 3,000 gallons. Carrying the example one more month, let's assume your meter reading for the second month is 3,900 gallons. The utility will only bill you for 1,000 gallons that month because the meter reading has reached the 3,000 gallon level, but has not yet passed the 4,000 gallon level.

Finally, it is not uncommon for customers who are switched from unmetered to metered service to be surprised that they are actually using more water than they thought they were. Although your initial meter reading seems high to you, it is in fact below the average usage that is used by our agency and other regulatory agencies in our regulation of the water and wastewater industry. The average usage per person is estimated to be 100 gallons per day. For a retired couple, this equates to approximately 6,000 gallons per month. Therefore, even considering your water conservation efforts, it is possible that you may have used 2,000 gallons in one month.

Many areas of Florida will be facing water quality and quantity problems in the future if efforts are not undertaken to preserve our valuable water resources now. I would like to commend you on your water conservation efforts. By monitoring your water usage over the next several months and checking for leaks, you should be able to determine if you are in fact using the amount of water for


