Good morning, Missie. Here is a recap of what I found. On December 5, 2001, I was provided a copy of your letter to Jackie Knight dated February 27, 2001 requesting cancellation of TTI's ALEC Certificate No. 4786 (TX359). That letter was not forwarded to technical staff so that it could be processed.

As information, before staff can recommend voluntary cancellation of a certificate, a company must be up-to-date on its regulatory assessment fees. I checked Commission records and found that Certificate No. 4786 was originally in Biz-Tel's name (TX065). Biz-Tel's ALEC certificate was transferred on 08/30/99 to TTI in Docket No. 990732-TP. Biz-Tel owes the 1998 and 1999 RAFs, plus statutory penalty and interest charges. TTI paid the 2000 RAF timely, so it is up-to-date.

You had told me in our conversation that Biz-Tel was audited by Ruth Young in November 2000 or February 2001 and Biz-Tel's RAFs should be up-to-date. I checked with Denise Vandiver, bureau chief over the Commission's auditing section, and was told that the Commission had completed an audit of Biz-Tel's IXC certificate, but that it did NOT include Biz-Tel's ALEC certificate.

Therefore, before we can process the voluntary cancellation, the 1998 and 1999 RAFs for Biz-Tel need to be paid. In addition, TTI's 2001 RAFs will either need to be paid or the company must provide a date certain they will be paid (2001 RAFs are due January 30, 2002), pursuant to Rule 25-24.820, F.A.C.

If you find that Biz-Tel's ALEC returns for 1998 and 1999 were filed, please provide me with a copy of the check (front and back) and the returns and we'll research further. Call me if you have any questions or need the return forms for those years (or if you need TTI's 2001 return). Thanks, Paula

The amount of RAF paid by TI351 does not look like an unusual amount compared to prior years. However, if they did in fact reported all their revenues under TI351, then they may have to file an amended return for TI351 to reflect the overpayment, and we can transfer the fees. If this is so, then 1999 fees could be easily taken care of. I'm not sure about 1998.

I will try to put this in a coherent message, but I can come down and talk to you and show you some of the work papers if it would help clear it up.

In February, 1999 we completed an audit of the 1997 Biztel TI351 RAF, and found no problems.

In February, 2001 we completed an audit on the 1999 Biztel **Ti351** RAF. The audit was initiated because Stephanie Cater had some concerns about the percent of sales reported as intrastate. (20% vs. avg industry of 30-40%) The company could not justify the percent, but it was consistent with prior years reported by Biztel, and Biztel was under new management, so we (Stephanie and I) decided to accept the 20%. We did not look at Biz-Tel TX065 and TTl National TX359. However, the Tl351 1999 RAF reported \$19,149,168 in Florida Gross Revenues. This number agreed to a Biztel Corporation Income Statement. While most of the work papers in this audit were confidential, it does appear that some of the specific accounts that contribute to the \$19 million may be related to the TX certificate - for instance, accounts are named LEC Billed revenue and PICC revenue. So **MAYBE**, for 1999, Biztel reported all revenue under one certificate. We did not catch that in the audit and comment one way or the other.

I don't believe we have ever audited TTI RAF
