Staff reviewed the documents in Document No. 00313-02. Included are staff comments in matrix form, which parallels the justification matrix that Florida Power Corporation (FPC) filed as part of its confidentiality request.

Staff believes that much of the information is dated and may have appeared in other, nonconfidential documents provided to regulators, investors, and others. Staff notes that FPC's concern with SEC Regulation FD may be too broad since investors are aware that utilities provide large amounts of information to regulators. Still, in an abundance of caution and because much of the information is related to the now consummated acquisition, staff chooses overall to go along with FPC's request on much of the information. Staff provided an explanation in the matrix for pages that it believes are not confidential. Those exceptions appear in bold type.
