NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE TO PROVIDE INTEREXCHANGE TELECOMMUNICATIONS SERVICES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Global Business Solutions and Services, Inc. (Global Business Solutions and Services) has applied for a certificate to provide Interexchange Telecommunications (IXC) services pursuant to Section 364.337, Florida Statutes. Upon review of its application, it appears that Global Business Solutions and Services has sufficient technical, financial, and managerial capability to provide such services. Accordingly, we hereby grant Certificate No. 8035 to Global Business Solutions and Services.

If this Order becomes final and effective, it shall serve as Global Business Solutions and Services' certificate. Global Business Solutions and Services should, therefore, retain this

Order as proof of certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.337, Florida Statutes.

IXC providers are subject to Chapter 25-24, Florida Administrative Code, Part X, Rules Governing Telephone Service Provided by Interexchange Telephone Companies. IXC providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to Global Business Solutions and Services for payment by January 30th. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve Global Business Solutions and Services from its obligation to pay RAFs.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that we hereby grant Certificate No. 8035 to Global Business Solutions and Services, Inc., which shall authorize it to provide Interexchange Telecommunications services, subject to the terms and conditions specified in the body of this Order. It is further

ORDERED that this Order shall serve as Global Business Solutions and Services, Inc.'s certificate and should be retained by Global Business Solutions and Services, Inc. as proof of certification. It is further
