By letter dated February 22, 2002, Interstate FiberNet, Inc. ("IFN") notified Broadslate Networks, Inc. ("Broadslate") of the seriously past due nature of their account. IFN also advised of its intent to block the account and take further action to collect the account should payment not be received.

On February 28, 2002, Broadslate notified IFN of its intent to cease operations on Friday, March 15, 2002 and forwarded a partial payment of \$30,000.00, leaving an account balance of \$102,409.34. This letter serves to notify the Commission that due to default of payment obligations under their contract, IFN's intends to block, suspend and disconnect services provided to Broadslate within the state of Florida as of 4:00 p.m. CST on Friday, March 15, 2002.
