Dear Mr. Susi:

On March 5, 2002, the Commission received the 2001 Regulatory Assessment Fee (RAF) return form with the note "cancel certificate" written on it. Payment for the 2001 RAF, including penalty and interest charges, was not included.

As background, the RAF is assessed if a certificate is active for any one day during a calendar year and is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. If payment is postmarked after the due date, then statutory penalty and interest charges are applicable.

According to Commission records, Sprawlnet.com owes \$9.00 penalty (\$7.50) and interest (\$1.50) charges for late payment of the 2000 RAF, \$56.00 (\$50.00 RAF, \$5.00 penalty, and \$1.00 interest) for the 2001 RAF, and \$50.00 for the 2002 RAF, or a total of \$115.00 if payment is postmarked by March 31, 2002.

The effective date of a voluntary cancellation is the date that the Commission received a company's request for cancellation. In this case, the Commission received your request for cancellation on March 5, 2002, therefore, the company will also owe the 2002 RAF, even if the company is no longer in business or, in fact, never went into business. Rule 25-24.474, Florida Administrative Code, provides that a company requesting cancellation must either pay the current year's RAF (2002) or provide a date certain that it will be paid, such as within 30 days after the Commission Order is issued granting the voluntary cancellation. The 2001 and 2002 RAF return forms are enclosed.
